When your Jury Application Form is received with photographs and Jury Application Fee:

You will be juried into accepted, stand-by or declined by April 1<sup>st</sup>.

If you are accepted, you will receive an invitation to register in the spring. The strict registration deadline is May 1<sup>st</sup>. **If you registration is late you may lose your space.**

If you are juried into the Standby File, you will be notified via email and you may be accepted any time before the event, if space in your category becomes available.

If you are juried into declined (not invited this year) you will be notified by email, and you may reapply in future years.
